**SUPPORTING THE DEPARTMENT OF THE INTERIOR'S PROPOSED
ADMINISTRATIVE WITHDRAWAL OF FEDERAL LANDS AND MINERALS
SURROUNDING THE CHACO CULTURE NATIONAL HISTORICAL PARK**

WHEREAS, the All Pueblo Council of Governors is comprised of the Pueblos of Acoma, Cochiti, Isleta, Jemez, Laguna, Nambe, Ohkay Owingeh, Picuris, Pojoaque, San Felipe, San Ildefonso, Sandia, Santa Ana, Santa Clara, Santo Domingo, Taos, Tesuque, Zia, and Zuni, and one pueblo in Texas, Ysleta Del Sur, each having the sovereign authority to govern their own affairs; and

WHEREAS, the purpose of the All Pueblo Council of Governors is to advocate, foster, protect, and encourage the social, cultural, and traditional well-being of the Pueblo Nations;

WHEREAS, through their inherent and sovereign rights, the Pueblo Nations through the All Pueblo Council of Governors will promote the language, health, economic, cultural, and natural resources, and educational advancement of all Pueblo people;

WHEREAS, the 20 Pueblos possess inherent government authority and sovereignty over their lands;

WHEREAS, the Pueblos possess their own cultural territory and sovereign right to protect their cultural resources, including their traditional cultural properties and sacred sites, whether or not these cultural resources are located within each Pueblo's current exterior boundaries;

WHEREAS, the All Pueblo Council of Governors recognizes that the Greater Chaco Region, including the Chaco Culture National Historical Park ("CCNHP") situated within it, is a sacred landscape important to Pueblos and other Tribes;

WHEREAS, the All Pueblo Council of Governors has long raised concerns about the effects of oil and gas development in the Greater Chaco Region, where such development is encroaching closer and closer on CCNHP;

WHEREAS, the All Pueblo Council of Governors has maintained a two-part approach to protecting CCNHP and the Greater Chaco Region that includes: 1) seeking withdrawal of federal lands and minerals from future mineral development in an especially critical approximately 10-mile withdrawal area surrounding CCNHP and including its outliers; and 2) seeking sufficient tribally-led cultural resource studies and tribal

WHEREAS, the All Pueblo Council of Governors reaffirmed its support for legislation withdrawing federal lands and minerals in an approximately 10-mile withdrawal area surrounding the CCNHP and including its outliers from mineral and geothermal development and leasing; and

WHEREAS, during the White House Tribal Nations Summit in November of 2021, President Biden announced that the Department of the Interior (Department) through Secretary Deb Haaland of Laguna Pueblo would begin the administrative withdrawal process for a 20-year withdrawal of federal lands and minerals from future mineral development in the approximately 10-mile withdrawal area surrounding the CCNHP;

WHEREAS, The Department officially began this process by publishing a Federal Register Notice on January 6, 2022;

WHEREAS, the proposed withdrawal would remove 351,479.97 acres of public lands from location and entry under the United States mining laws and from leasing under the mineral leasing laws, but not disposal under the mineral materials laws, and the withdrawal would be subject to valid existing rights; and

WHEREAS, the Department is now following the administrative withdrawal process required by the Federal Land Policy and Management Act before making a final decision on whether to complete the withdrawal;

NOW THEREFORE BE IT RESOLVED THAT, the All Pueblo Council of Governors applauds President Biden and Secretary Haaland for initiating the administrative withdrawal process.
